CHIEF MASTER SERGEANT CHAD T. WELCH

CMSgt Chad T. Welch is the Command Chief Master Sergeant, 932d Airlift Wing, Scott Air Force Base, Illinois. Chief Welch leads the enlisted force and advises commanders on matters impacting the enlisted force, such as proper utilization, readiness, professional development, training, and quality of life issues. He ensures the commander's policies are widely publicized and understood by the enlisted force, and serves as the functional manager for all assigned first sergeants.

Chief Welch enlisted in the United States Marine Corps in July 1989. Upon completion of technical training he was assigned to the Marine Corps Security Forces detachment in Charleston, S.C. During this time he worked at the special weapons facility and participated in S.T.A.R.T. treaty inspections involving International and Russian inspectors. In November 1992, he was transferred to Marine Corps Headquarters, Quantico, Va., as an Officer Candidate Instructor and served as a marksmanship instructor until the end of his enlistment in July 1993, at which point he embarked upon his civilian career. In October 2001, he enlisted in the Air Force Reserve. After completing the Fire Protection Academy, he was assigned to the Fire Protection Flight, 932d Civil Engineer Squadron, Scott AFB, III., where he served in



various fire protection positions. In January 2011, he was selected as First Sergeant, 932d Aeromedical Evacuation Squadron, Scott AFB, III. Prior to his current position, the Chief was the First Sergeant, 932d Security Forces Squadron, Scott AFB, III.

During his career, Chief Welch completed three home station deployments at Scott AFB, III., as well as a tour in Saudi Arabia in 2003. In 2008, he served as the station captain for a five-month deployment to Kirkuk, Iraq. Then, in 2012, he was selected as First Sergeant, 406th Air Expeditionary Squadron, Kandahar, Afghanistan, where he completed a complex seven-month deployment that required extensive travel outside the wire and around the country. In his civilian capacity, the Chief is a District Manager with a major company and also serves as a part-time Mental Health Counselor.
